➤ **Independent Living:** Apartments for seniors (55+) offering options for additional amenities such as dining options, transportation, social activities, housekeeping, Fees may be incorporated into the rent or purchased separately on an à la carte basis. Personal care and nursing services may be purchased through a homecare agency.

This is my second month in office and I continue to learn so much! One thing to share this month is the wealth of resources available on the City of Rochester's website, www.cityofrochester.gov. While my legislative aide, **Chuck Stechna**, and I are happy to answer any questions you may have (428-5982), a visit to the website might also be able to answer them and help you uncover other interesting details as well. I have been particularly impressed with the use of Geographic Information System (GIS) software and mapping programs. By visiting www.cityofrochester.gov/nbd and clicking on the "NBD Map Gallery," you can look at neighborhood data by census tract; see individual vacant lots and structures; and track business permit applications and approvals by parcel, among other things. More broadly, a visit to www.cityofrochester.gov/maps can get you crime reports by neighborhood, data on recent housing sales, and information on parking garages and

enforcement, for example. The website also is a great resource for City-sponsored programs and events, and for the real policy works among us, the City code and charter, legislative agendas and a host of other information are all online.

My initial "office hour" at the Cannonball Café on February 6th went well – it was nice to be able to chat with neighbors in an informal setting on a variety of Charlotte and city issues. We talked about the plans for the Marina opening (slated for the first week in May) and the upcoming announcement of the leasing of some of the port terminal space, including the old Pier 45. Security in the Turning Point Park parking lot continues to be an issue that I will work with the City administration to address. Hope you will join me at future office hours at the Cannonball at Lake and Latta, the first Saturday of the month at 11:00 am. Creative Beginnings – Lakeside offers New Early Pre-Kindergarten Program

At Creative Beginnings-Lakeside our newest program, Early Pre-Kindergarten (EPK), started on January 4, 2016. The program is for City of Rochester children who are three years old by December 1st, and it is free. If you are interested, the enrollment process begins by contacting the main office of the Rochester City School District, located on Broad Street. This is a lottery program and, if chosen, you will be allowed to choose your top three locations. We very excited to provide our community access to this program. Right next door to our EPK program is our Universal Pre-Kindergarten (UPK) program. This is another free program provided by the Rochester City School District for four-year olds. Both of these programs operate from 9am until 3pm Monday thru Friday.

At Creative Beginnings - Lakeside we have openings in our toddler and school-age rooms. We provide the children with many fun filled programs and activities: arts and crafts, singing songs, and reading, to name a few. In addition, we provide assistance with homework and reading assignments. Located at Creative Beginnings-Lakeside is a large-motor muscle room and lots of interesting and engaging toys to burn off some of that extra energy, and get those bodies moving. The staff will provide your child(ren) with a safe and loving environment to flourish in. We also offer wrap around care for both of these programs. We have an open door policy so if you are at all interested please feel free to stop by for a tour and further information about these programs and the curriculum.

Update: New York State Senate Joe Robach

NYS Senate Takes Action to Combat Synthetic Drugs

Recently, I've had many discussions with police officers, substance abuse counselors, and parents about synthetic cannabinoids; legal, yet dangerous, drugs that can have life-altering consequences and recently voted on a package of bills aimed at combating these harmful drugs.

The Senate-approved legislation designed to identify new drugs that currently evade our existing laws, ban chemicals that mimic controlled substances, and establish a database of these deadly chemicals to better inform the public and law enforcement. Additionally, we have released a report showing the State fiscal ramifications from synthetic-cannabinoid use; specifically identifying that New York State and its taxpayers footed a \$22.7 million bill in 2015 responding to this major public health problem.

The Senate has passed similar bills combating synthetic cannabinoids in the past, but the Assembly refuses to address this issue. It is past time for the Assembly to join us and help put an end to synthetic-drug abuse today.

The spread of synthetic drugs is affecting every community and will continue to destroy lives unless more preventive action is taken. We are committed to eradicate this threat and will be sure to keep you posted on our ongoing efforts.

This Spring**

The Port of Rochester Marina will be opening May 1st for the boating season! The finishing touches will be completed in March and April, including dock installation and completing the opening into the river. The new state-of-the-art marina will feature 54 seasonal slips, and approximately 20 guest slips within the basin, with many quality amenities. Boaters will enjoy gangways with secure access to docks, electric, water, Wi-Fi, deck boxes, a pump out station and regularly scheduled social events.

New boater services within the port terminal building will soon begin construction that includes new showers and restrooms, a boater's lounge, ship store, laundry services, and a fulltime on-site Marina Manager. This construction will be complete early in the season, providing the highest level of quality amenities. With a new legislature cycle upon us, it has been great to get back to work as your County Legislators. 2016 has brought new faces to the Legislature due to term limits and elections. We look forward to helping our new colleagues learn how to best serve the residents of Monroe County.

There is also a new leader in the County Executive's office, **Cheryl Dinolfo**. Cheryl made integrity and government transparency an integral part of her campaign. In January, the Monroe County Legislature introduced a local law, sponsored by the County Executive, which will create the Office of Public Integrity. This new office will have independent authority to examine all County operations and report their findings to the legislature and law enforcement, as necessary. This will ensure that your money is being used appropriately.

Legislator **Tony Micciche** also introduced a law that will help make our community a safer place, the Neighborhood ZOMBIE Act. Vacant properties are an eyesore and safety hazard in our community. These homes are often havens for criminal activity such as drug trafficking, vandalism, and arson. Despite the best efforts of law enforcement, monitoring these zombie properties is difficult due to the lack of a master list that identifies their locations. Tony's local law will create a registry so municipalities can monitor these homes and make sure the banks maintain the property while it is in foreclosure.

We look forward to continuing to pass legislation that helps Charlotte, a community that we are proud to represent in the County Legislature. SS Edmund Fitzgerald Topic of March Marine History Group

On March 12, 2016, **Tom Brewer**, Chairperson of the Marine History group of the Charlotte- Genesee Lighthouse will show a video about the history of the SS Edmund Fitzgerald that sank in 1975.

The SS Edmund Fitzgerald's wreckage sits 530 feet below Lake Superior's surface. The meeting will be at 10:00 AM at the Custom House, 10 Latta Rd. at the corner of River St. & Latta Rd. It is free and open to the public.

Road Repairs Coming To The Lake Ontario State Parkway!

Tom Brewer, CCA member, received a letter from the New York State Department of Transportation that it is planning to resurface the Lake Ontario State Parkway from Route 390 to the Colonel Patrick O'Rorke Bridge in the Town of Greece and the City of Rochester. The project includes the resurfacing of the ramps at the Route 390, Dewey Avenue, Greenleaf Road and Latta Road interchanges.



Additionally, they will repair a section of noise barrier wall near Lake Avenue.

Traffic will be maintained using lane closures with at least one lane open in each direction throughout the project. Work on the interchange ramps will require short term closures with posted detours.

Construction is expected to begin in the spring of 2016 and be completed by the fall of 2016. Stay tuned for updates!

- **Assisted Living Residence/Enriched Housing:** Regulated by the NYS Department of Health. Services traditionally include 24-hour staffing, assistance with personal care and medications, 3 meals per day, transportation, housekeeping, laundry services and recreation programs. Payment options include private pay, long-term care insurance and SSI. Services, amenities and payment type may vary per community.
- **Assisted Living Program:** Serve persons who are medically eligible for nursing home placement but serve them in a less medically intensive, lower cost setting. They provide personal care, room, board, housekeeping, supervision, home health aides, personal emergency response services, nursing, physical therapy, occupational therapy, speech therapy, medical supplies and equipment, adult day health care, a range of home health services and the case management services of a registered professional nurse. This is the only Medicaid option for assisted care.
- **Transitional and Rehabilitative Care:** Inpatient rehabilitation is temporary care to help patients regain strength and conditioning so that they can return home from a hospital or nursing home, or move to a lower level of care. It is regulated by the NYS Department of Health and payment options include Medicare, Medicaid, private and third-party insurance.
- **Skilled Nursing:** Regulated by the NYS Department of Health and provides 24-hour care for individuals with serious or chronic health issues who require consistent clinical oversight

or total assistance with activities of daily living. All skilled nursing homes accept private pay and long-term care insurance; most also accept Medicaid after residents spend down assets, however they may require private funds be available upon admission.

- **Memory Care:** Specialized care designed for people diagnosed with Alzheimer's disease or dementia. Special training, increased staffing, structured programming and a secure environment are the hallmarks of a memory care program. These programs are often an extension of Assisted Living Residences and Skilled Nursing Facilities.
