CITY OF ROCHESTER UPDATES

Rochester Police Department (RPD) - Lt. Radke

- o Memorial Day Beach detail. All went well
- o In May there were two car breakins and one stolen car.
- o Please join us for the community outreach event in July.

Rochester Fire Department (RFD) Engine 19 - Capt. Scott Daily

- Responded to a car fire at Brothers Collision and one water rescue at turning point park.
- A boat sank in the Marina,
- A fire boat is on order. 38 foot, fully equipped will be delivered in 2020.

Northwest Neighborhood Service Center (NSC) - No Report

City Council NW Representative – Molly Clifford

- City Council is looking at legislation to allow motorized scooter in the city, similar to the rentable bikes.
- City budget was released on May 19. There are two review sessions upcoming. Major items, RFD staffing, proposed brown outs of companies. Recand Youth Services are being changed. Community Development, Demolition of housing that cannot be saved, Energy assistance, Homelessness/Foreclosure and Sr. Legal Services. There is an increase in fees. The entire budget is available on line.
- Mayor is offering a plan for complete School District restructure.
- Maplewood Rose Festivalis June 8.
- Letters are being mailed regarding a full reassessment in 2020.
- o There were no acceptable proposals for the Parcel 1 RFP. To be reworked and put out again.

- o Explained the proposed brown out proposal for next year.
- Union feels this is a bad move.
- The union did ask for a study to be done by Finch Associates in the hope of improving response time and service. Charlotte was not included in the study. Instead of using the entire study the



City has chosen to use only the items suggested to save money. As a result, response time may be longer. They provided examples of the result of other cities using this brown out policy.
