

Board of Directors Meeting

Call to Order at 6:30 Board in attendance. Lindy L. absent

GUESTS: Jonathan Hardin re: fundraising for JROTC

A discussion began as to the money held in the CCA account for the JROTC. The goal for 2020 was \$1,000. Currently they are short \$98.00 to reach that goal. Jonathan says the money is spent for travel expenses to sporting events for their color guard participation. It was voted on that we will write a check to this group for \$900 to Eric Meister which includes the shortfall of \$98. Additionally, we are adding the \$275 sponsorship to CYAA to the Youth Engagement Committee which Jonathan chairs.

- FOIL request: Ontario Beach Park –this is for the park agreement. It is for 99 years. Owned by the city and managed by the county. This agreement was signed in 1961 and will come under review in 2030. We need to discuss the correlation between this review and the 2034 plan.
- CDCR workgroup- Sue informed us that Maria has a new work group starting that might be able to do some of our items from the Charrette. There is finally the \$15,000 available from Joe Morelle. This money was based on our community's ability to raise money as well. There is a July 1st deadline. Sue to follow up with Maria.
- Status of RFP Gary Kirchmeier's assistant says they are close to making a decision on the RFP.
