

GENERAL MEETING MINUTES November 2, 2020 | Via Zoom

7:00 pm Call to Order – Meeting was called to order at 7 PM by President, Sue Roethel., Also in attendance Vice President, Patti O'Brien, Treasurer, RoseMary Shaw and Directors Linda Litwak and Tony Micciche. CITY OF ROCHESTER UPDATES

Rochester Police Department Lt. Waldo – discussed the pop up "club" that opened in the 4400 block of Lake. This building was being renovated for a liquor store, but there were several large groups on 3 evenings. The building owner was notified and is taking care of the issue. Lt. Waldo also discussed the call for shots fired at 320 Beach Ave. The shots were fired into a vehicle. No one was hit. It is an ongoing investigation. There were 3 burglaries, 0 car break ins. There was a question regarding the armed robbery at Dunkin Donuts at Denise and Lake Ave. There was a discussion on the issue of numbers of the police force who are retiring and new classes. The November PCIC meeting will be on 11/17 at 7 pm via Zoom. Captain Cornell discussed the traffic unit working on Lake Ave. to work on the speeding and accidents. The problem with the "car shows" and racing in the NW area was discussed. 4-wheelers running through the Cherry/Falleson/Harding area was discussed, particularly one group who rides at 4 am. Capt. Cornell told members to continue to call 911 when the ATV's are out. The Captain also requested that any ideas or suggestions to address crime in our area could be sent to our CCA general email and RoseMary will compile them to forward to him.

Fire House – No one in attendance

NWNSC – Tammi Herron went over the leaf collection calendar. The grant for the Restaurant meals for Seniors has ended but will start another session. Public service announcements will come out in a few weeks. Seniors can call 211 to request meals. Bruce Wilder was asked about issues with the 7/11 at Lake and Stonewood. Bruce indicated that he had stopped at the store and discussed the trash problem and will continue to check on its progress.

City Council Jose Peo – Jose Peo asked that anyone concerned about the low numbers on the force to call in to the Speak to Council. Many officers are getting their 20-year anniversaries and contemplating retirement. Jose reminded everyone of his Facebook page and mobile app. He is conducting a food drive for Thanksgiving from November 17th through the 20th.
